Q: How long have you been in business?

I have served for many years as a policy consultant to the California State Assembly and Senate and served as Assistant Chief Deputy and Counsel to the California Secretary of State. I dreamed of being an Astronaut, because I was fascinated by the US space exploration program. When I was a young adult, I dreamed of having a very successful career but also raising children. Looking at traditional corporate careers, I could not see a path for how to make that possible. As the oldest of five children growing up, I was extremely impressed by my own mother who—in the 1970s when the women's liberation movement was happening—went back to school nights to finish first a B.A. and then a Master's Degree, and then when the five of us kids were school age, she entered the workforce and began a career in politics. It seemed she had endless energy, because she would work a full day and then come home and cook dinner and help the little ones to bed before

sitting down to prepare for the next workday. I think I learned from her that being a women and "wanting it all" meant that I would have to be prepared to work hard, always. It helped me prepare for raising children and pursuing a career. Of course, I am very fortunate. My spouse has been very supportive and took on a major role in raising the kids and supporting the family when I went to law school.

Q: What was one of your biggest challenges in starting a business or joining the team?

It is always a big leap of faith to set out on your own and start a business. It is still a leap of faith, even today after having the business for 10 years—this year is Davis Wills & Trusts 10 year anniversary! You always worry about income next month, next year, expenses rising, etc. But you learn to have faith in your client base and in the community that they will help your practice thrive so that you can survive and continue serving your clients, their families and the community in general.

Q: What advice would you give to other women trying to develop a business?

Just do it! You can always go back to what you were doing before if it doesn't work out. For me it has always felt better to DO the

thing you are dreaming of than to worry about failure and not do the thing. Not doing can lead to procrastination, missed opportunities and regret, and you don't want to look back at your life and wish you had taken that leap!

I think women often bring a special sensitivity to their clients' and customers' needs and level of caring about their clients, customers and colleagues that is often missing in the traditional model of "running a business." My father died when I was fairly young, and it gave me an insight into the detailed planning that needs to be done in order to ensure that family relationships - and family finances—stay intact after death. I wanted to help other people get their estate planning done right and done thoroughly.
